The August 2, 2019 Stated Meeting of the Synod Assembly of the Synod of the Covenant, Presbyterian Church, (U.S.A.), was called to order by Moderator Aaron Meadows at 10:05 a.m. The meeting was held at the First Presbyterian Church of Maumee, Ohio.

Moderator Aaron Meadows offered the opening prayer at 10:05 a.m.

The lighting of the Christ Candle took place.

The Stated Clerk declares that a quorum is present. The Synod of the Covenant Bylaws Article IV, D, 5 specify that a quorum for a meeting of the Synod Assembly shall consist of ten commissioners made up of five ruling elders and five Ministers of the Word and Sacrament. #### PRESBYTERY PRESENTATIONS (Attachments CC, DD, EE, and FF)

Bill Bogdan, the Vice-Moderator of the Presbytery of Cincinnati reported on some of what is going on in the Presbytery of Cincinnati. This is s time of transformation and transition. The Transformation started in March of 2017 with a prayerful time of discernment that involved evaluation and imagination. There is now a new thinking about covenant partnerships. The Presbytery has rewritten their bylaws. The roll of Presbytery functions as a relational catalyst, resource center and regulatory agency. They are also in a time of transition ss they are now in the process of searching for a new Executive Presbyter.

Stefanie Lewis, the Moderator of the Presbytery of Detroit, indicated that the Presbytery of Detroit is in the fourth year of a five-year plan to strengthen congregations and improve communications between the Presbytery and congregations. This year the focus was on the pastoral part of the mission statement which is: " Strengthening and Transforming Our Congregations to be Missional, Pastoral, and Prophetic. The Presbytery of Detroit has voted to become a Matthew 25 Church. The Presbytery is awarding a series of larger grants coming from an anonymous contribution of over \$320,000 to be used by churches that make a difference in their community.

Richard Lapehn, the Moderator of the Presbytery of Eastminster, indicated that the geographic area of the has had a population loss. However, every congregation has support financially for books and supplies for schools related to Syria and Lebanon. There have been two teams that have traveled to Lebanon. There are twelve pastors who are participating in the Board of Pensions Healthy Pastor, Healthy Congregations program. Four Pastors have completed the program. The Presbytery does have a Disciple Feast in October.

Ted McCulloch reported for the Presbytery of Lake Huron. While there is stability with the Presbytery Executive, all the churches in the thumb of Michigan are vacant. There are 17 vacancies out of 39 churches. The Mission Committee has bought back small grants to help with programing. The PDA film "The Poisoning of an American City" is about the water crisis in Flint.

Drucilla Wrasse, the Vice-Moderator of the Presbytery of Lake Michigan, informed us that the Transitional Executive Staff is being shared between Calvin Bremer and Fran Lane-Lawrence. There now four regional gatherings within the Presbytery. There is congregational sharing and the Presbytery has discovered that this does help with networking. There will be 23

congregations working on Vital Congregations in 2020. The Presbytery of Lake Michigan has a mission plan that has four steps: define your ministry purpose, evaluate your ministry, next steps for 2020, and working the plan.

Bill Myers, the Moderator of the Presbytery of Mackinac, wanted to thank the Synod for the Administrative Commission that helped identify issues within the Presbytery and noted that a Committee from the Synod is still helping in this process. Three churches sent youth to Triennium. Some churches are exploring the Vital Congregations program. Because there is not a General Presbyter there are three or four people who function as one.

Bruce Saunders, the Moderator of the Presbytery of Miami Valley, reported that the new Executive Presbyter Terry Kukuk has had a busy first year. Then a tornado on May 27, 2019 struck the Dayton area. Representatives from Presbyterian Disaster Assistance met with the Presbytery on May 31. An initial grant of \$7,500 was received and member churches and members contributed \$20,000. Church World Services provided 180 clean up buckets, 60 hygiene kits and 60 blankets. The response was God's people doing God's work. This year the Presbytery is having a focus on a section of the Book of Order. With the Presbytery of Cincinnati there has been a training in conflict management and reconciliation led by the Lombard Mennonite Peace Center.

Anne Weirich presented the report for the Presbytery of Muskingum Valley. The Presbytery is trying to right size itself. They have sold a building and have moved the Presbytery Office into the First Presbyterian Church in Uhrichsville. The Presbytery has started on-line sharing, becoming an inside out faith, there is a new Chinese Congregation associated with the First Presbyterian Joe with a \$1,000 grant to the congregation for the Pastor who logs the most cups of coffee. Anne Weirich also reported on the New Covenant Grant that received funding for the Addiction Coalition of New Concord.

Rebecca Tollefson, the Presbytery of Scioto Valley Moderator and past executive director of the Ohio Council of Churches, offered the report for the Presbytery of Scioto Valley. There are 94 congregations and there are two new fellowships, one is Indonesian and the other is from Cameron. The Presbytery commission structure is working well to meet the needs of the Presbytery. Scioto Valley will be hosting General Assembly in Columbus June 25-July 2, 2022. They do hope for volunteers and financial support. Jimmie Hawkins of the Office of Public Witness in Washington, D.C. will be in the Presbytery September 14-17, 2019. Three of the younger Pastors in the Presbytery have developed a Pod Cast under the heading of Bad Calvinists.

Susan Vlcek presented the report for the Presbytery of Western Reserve. Sharon Core, the Executive Presbyter is presently recovering from knee replacement surgery. The Presbytery of Western Reserve has been focusing on purpose. There is an effort to have spiritual renewal for individuals and for congregations. Outreach includes congregational partners, ecumenical partners, and international partners. There is an effort for justice for undocumented persons.

The Nominating Committee has made an effort to connect with Moderators of the Presbytery Committees so they can grow in their work together.

Gillian Holzhauser-Graber reported for the Presbytery of Maumee Valley. Matt Meinke is the new General Presbyter. The Committee structure of the Presbytery is being reorganized and should be in place in 2020. There were 24 people who went to Triennium from the Presbytery of Maumee Valley. There have been some members of Presbytery trained to lead boundary training workshops. There is a Presbytery wide youth retreat scheduled for November.

# **MODERATORS' COMMITTEE REPORT (Attachment GG)**

Aaron Meadows presented the Moderators' Committee Report. Aaron Meadows invited Raafat Zaki to speak to the Synod of the Covenant becoming a Matthew 25 Church. On motion the Moderators' Committee recommends to Synod Assembly that the Synod of the Covenant Become a Matthew 25 Church. The motion passed.

The Moderators' Committee has established the following Synod Assembly dates for 2021. They are March 13, 2021 at Weber Center in Adrian, Michigan, August 6, 2021 at the First Presbyterian Church in Maumee, Ohio, and November 5-6, 2021 at the Christ Presbyterian Church in Toledo, Ohio. Prior to the March 13, 2021 Synod Assembly there will be a retreat for Commissioners and invited guests on March 11-12, 2021.

#### SELF DEVELOPMENT OF PEOPLE REPORT (Attachment HH)

Aaron Meadows invited Lois Aroian to report on the work of Self Development of People. She encouraged Presbyteries to promote possible projects for projects.

#### LUNCH

Aaron Meadows offered a prayer for lunch at 12:19 p.m.

#### MOBILE HEALTH FAIR REPORT

Aaron Meadows asked if the Mobile Health Fair Report could be moved up. This morning was the final Mobile Health Fair for the summer. Lisa Florez is the Mobile Health Fair Coordinator. The summer team of Samantha Florez, George Kim, Madison Huffman, Antonio Salinas, Aiyah Shepard, and Leah Tressel reflected on their summer experience. They reported that 990 individuals were served. Age appropriate books were handed out for the youth to promote education.

After the report Aaron Meadows called for the Order of the Day.

# LISTENING SESSION WITH THE GENERAL ASSEMBLY SPECIAL COMMITTEE ON PER CAPITA BASED FUNDING & NATIONAL CHURCH FINANCIAL SUSTAINABILITY

Paul Helphenstine and Timothy Ngare lead the listening session with for the General Assembly Committee. The Synod Commissioners participated in the discussion. The information

provided will be included in the Special Committee discussion and evaluated for their final report.

#### TREASURER'S REPORT (Attachments II and JJ)

David Bartley, Synod Treasurer, presented the Treasurer's Report. The final loan payment has been paid to the Synod, so there are no more outstanding loans. The expenses are on target. Per Capita received is what would be expected. The Basis Mission giving is down. But this reflects the mission giving that is coming to Presbyteries from the congregations.

# COMMITTEE ON REPRESENTATION AND INCLUSIVENESS REPORT (Attachment KK)

Pat Megregian presented the nomination for the Committee on Representation and Inclusiveness.

On motion the Committee on Representation and Inclusiveness nominated for the Synod of the Covenant Permanent Judicial Commission in the Class of 2022 from Detroit Stefanie Lewis. Nominations were asked from the floor. There were none. The motion passed.

It should be noted that there are two vacant positions for the Synod of the Covenant Permanent Judicia Commission. They are for the Class of 2024 from Lake Huron and for the Class of 2024 from Muskingum Valley.

# SYNOD EXECUTIVE'S REPORT

Raafat Zaki, Synod Executive reported that work is being done on the Website. A giving portal is in place to accept donations.

The Mobile Health Fairs have included offering books.

The Mission to the USA program is planning on 5 Mission Partners from Africa. Three of them have a Visas This is the third year with a focus on Christian Muslim relations.

Raafat Zaki announced that a \$5,000 grant through the Welcome All Refugees Program has been given to a church in Michigan that is going to use the money to rehab a house so young people can have a place to stay.

CECA has had three meetings and is making progress.

The Committee for Mackinac is doing well in their work with the Presbytery and the Coordinating Council.

The Ohio Council of Churches will be celebrating their 100<sup>th</sup> Anniversary on September 6, 2019. Raafat Zaki, through the Synod of the Covenant support, is the only Presbyterian leader engaged with the Ohio Council of Churches.

Raafat reminded the Committee Moderators of the need to get budget requests into the Board of Trustees by September 1, 2019.

# ADJOURNMENT AND CLOSING PRAYER

There was a motion to adjourn and close with a prayer. The motion was seconded and passed. The meeting was closed with prayer by Pat Megregian at 3:02 p.m. on August 2, 2019.
